

AGREEMENT FOR CONTENT CREATORS

IP RIGHTS POLICY FOR THUNDERDOME

Event: Thunderdome 2017
Location: Jaarbeurs, Utrecht
Date: 28-10-2017

By agreeing to this consent I declare that I have read, understood and therefore agree with the below policy and statement of Thunderdome B.V., a company with limited liability with registered offices at Overhoeksplein 31, 1031 KS Amsterdam, the Netherlands, hereinafter referred to as "TD", referring to the event named Thunderdome taking place at the Jaarbeurs Utrecht, the Netherlands on the 28th of October 2017, hereinafter referred to as the "event", and will take into account the rules specified underneath:

1. By applying for the event as media you are attached to the obligation of publishing the content you have applied for, consisting of a report of the premiere, in exchange for free entrance. If you choose for an angle that differs from a party report, this needs to be approved by TD.
2. You will have no access to backstage areas and you are not allowed to take photographs and/or films backstage without prior written approval of TD.
3. Interviews with artists must be requested prior the event, to the designated press contact of TD.
4. Flyers, tickets or business cards may not be distributed at the event without prior written approval of TD.
5. You are not allowed to publish photographs and/or films containing logos or brands of sponsors other than the official partners of the event.
6. In exchange for making photographs and/or films, you will have free entrance to the event and you are allowed to publish the photographs and/or films for your own (non commercial) reference.
7. By agreeing to this declaration, you transfer and assign all copyrights of all photographs and/or films taken at the event to TD in perpetuity. You also explicitly waive your moral rights in respect of these photographs and/or films. You are explicitly not authorised to make the photographs and/or film available to third parties in any manner whatsoever, whether or not on a commercial basis, without the written consent of TD. TD is allowed to use these photographs, films and/or articles for all media and for all objectives, such as but not limited to publication during events, (live) television broadcasts, reproduction in the form of CDs and DVDs, merchandising, the offering of downloads, podcasts and streaming, internet, social media, (live) radio and/or television programs, films, use in print, promotion material and in commercials, whether or not in relation to TD, and/or its sponsors and/or the event and/or the trademark of the event, this exclusively at the discretion of TD.
8. When a third party is cooperating in the recording of the photographs and/or the films, you hereby guarantee that they transfer and assign all copyrights and all neighbouring rights which are vested in these photographs and/or films to you, in order to transfer these rights to TD.
9. The photographs and/or films will, at the latest, be delivered to TD on 01-11-2017.
10. Photographs, films and/or written articles are not allowed to be sold or given to any other media than mentioned in clause 1 above, without the prior written consent of TD.
11. TD will receive a copy of the draft article, photographs and/or films before they will be published and you will need TD's consent prior to publishing.

Should you not adhere to one of the above rules, TD and/or the Promoter has the right to remove you from the event, without any compensation and/or damage to be claimed by you in this respect.
